

Website Privacy Policy and Cookie Policy

This website is operated by Kristaval Keepsakes Limited. We take your privacy very seriously therefore we urge to read this policy very carefully because it contains important information about on:

- who we are,
- how and why we collect, store, use and share personal information,
- your rights in relation to your personal information, and
- how to contact us and supervisory authorities in the event that you have a complaint.

Who we are

Kristaval Keepsakes Limited ('we' or 'us') collect, use, and are responsible for certain personal information about you. When we do so we are regulated under the General Data Protection Regulations which apply across the European Union (including the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws.

The personal information we collect and use

a) The personal information you provide to us

We collect the following personal information that you provide to us: Name Address

Telephone Number Email

Confirmation of age is over 18 years

When making purchases through our website

b) The personal information you provide about third parties

If you give us information about another person, you confirm that the other person has appointed you to act on their behalf and agreed that you:

shall consent on their behalf to the processing of their personal data; shall receive any data protection notices on their behalf; and shall consent on their behalf to the transfer of their personal data abroad.

c) Cookies and similar technologies

A cookie is a small text file that is placed onto your computer or electronic device when you access our website. Similar technologies include web beacons, action tags, local shared objects ('flash cookies'),

and single-pixel gifs. Such technologies can be used to track users' actions and activities, and to store information about them.

We use these cookies and/or similar technologies on this website.

For example, we may use cookies to monitor and/or collect the following information:

How many times a customer visits the site or its associated Facebook or Instagram pages

Whether the visitor found the site via search engines such as Google

This information helps us to build a profile of our users. Some of this information may be aggregated or statistical, which means that we will not be able to identify you individually.

In addition, it should be noted that in some cases our cookies or similar technologies may be owned and controlled by third parties who will also collect personal information about you.

On the first occasion that you use our site, we will ask whether you consent to our use of cookies. If you do not, cookies will not be used. Thereafter you can opt-out of using cookies at any time or you can set your browser not to accept cookies. However, some of our website features may not function as a result.

How we use your personal information

We collect information about our users for the following purposes:

- identifying visitors and managing any accounts held with the company
- processing orders
- analyzing customer purchasing preferences
- customer profiling for the purpose of recommending further products

Who your information may be shared with

We may share your information with:

Law enforcement agencies in connection with any investigation to help prevent unlawful activity;

For the purpose of customer profiling

We will not share your personal information with any other 3rd parties.

Marketing

We would like to send you information about products, services, offers, competitions and our business which may be of interest to you. Such information could be sent by post, email, telephone, text message, or automated call.

We will ask whether you would like us to send you marketing messages on the first occasion that you provide any relevant contact information (i.e. on a purchase, signing up to a newsletter, entering a competition, etc). If you do opt-in to receive such marketing from us you can opt-out at any time (see

'What rights do you have?' below for further information). If you have any queries about how to opt-out, or if you are receiving messages you do not want you can contact us using the details provided below.

Recording of Personal information

The provision of the following information is required from you:

This is to enable us to do the following:

To process and deliver orders
Send electronic newsletters from time to time
Electronically send information relating to special offers and events
We will inform you at the point of collecting information from you, whether you are required to provide the information to us.

How long your personal information will be kept

We will hold your personal information for the following periods:

Name, address and email details will be held for 6 years in compliance with legal recommendations

With customer consent, email addresses may be retained for a longer period for the purpose of recommending future products

These periods are no longer than necessary in each case.

Reasons we can collect and use your personal information

We rely on the following as the lawful basis on which we collect and use your personal information:

consent
contract
legal obligation
legitimate interests

The legitimate interests relied upon are as follows:

To provide information to help combat fraudulent transactions or to allow the company to undertake its lawful business for marketing and general purposes

A consequence of our use of your personal information

The consequence to you of our use of your personal information is: Should a customer attempt a fraudulent transaction against the company, the company reserves the right to report such attempts to the relevant authorities and to provide any personal data to such relevant authority as is legally required or requested

Keeping your information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We will also use technological and organisational measures to keep your information secure. These measures may include the following examples:

Personal information is kept on a secure dedicated server

We have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Indeed, while we will use all reasonable efforts to secure your personal data, in using the site you acknowledge that the use of the internet is not entirely secure and for this reason, we cannot guarantee the security or integrity of any personal data that are transferred from you or to you via the internet. If you have any particular concerns about your information, please contact us using the details below.

Transfers of your information out of the EEA

We will not transfer your personal information outside of the EEA at any time.

Children and the validity of consent

Where we obtain consent from any user we will take reasonable steps to ascertain whether the user is over 18 years of age and whether the child is sufficiently informed to give valid consent.

What rights do you have?

Under the General Data Protection Regulation, you have a number of important rights free of charge. In summary, those include rights to:

- fair processing of information and transparency over how we use your use personal information
- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
- require us to correct any mistakes in your information which we hold

- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to
 us, in a structured, commonly used and machine-readable format and have
 the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing
- object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
- the object in certain other situations to our continued processing of your personal information
- otherwise, restrict our processing of your personal information in certain circumstances
- claim compensation for damages caused by our breach of any data protection laws

How to complain
